

**ORDINANCE NO. 1933**

**AN ORDINANCE OF THE CITY OF PLATTSMOUTH, NEBRASKA TO ESTABLISH FEES FOR CITY SERVICES; TO REPEAL ALL ORDINANCES AND RESOLUTIONS IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.**

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA:

Section 1: The City Council of the City of Plattsmouth has determined that the fee structure for services and products provided by the City shall be revised as follows (all rates subject to 7% sales tax):

**Military Discounts:** Retired and active military will receive a 10% discount on all memberships and a \$1 discount for daily admission. Proper ID must be presented for discount.

Wellness Only Memberships only have access to the upstairs fitness area and walking track. Aquatics Only Members only have access to the pool and aqua classes.

All other memberships have access to the entire building, Group X classes, Cycling classes and Aquatics classes as long as their age permits entry.

- b. Visitor's Daily Rate Adults: \$5.37  
Senior 55+ and Children 3-17yrs: \$3.83  
Allows access to Gym, Walking Track, Wellness area, and Pool. Does not include Group X classes, Cycling, and Aquatic classes
  
- c. **Grandparents Summer Pass:** Grandparents may add up to 3 grandchildren to their Active Membership during summer break (from last day of school until beginning of school based on the Plattsmouth Community School District calendar). Membership must be maintained during the pass period and a grandparent is required to be in the facility with the child.

1 grandchild: \$30.00 (\$10.00 per month for 3 months) green dot  
 2 grandchildren: \$45.00 (\$15.00 per month for 3 months) purple dot  
 3 grandchildren: \$60.00 (\$20.00 per month for 3 months) blue dot

**p. PCC Youth Program Fees:**

1 **Youth Sports Fees and Length:** \$30 Members; \$40 for Non-members per child for 8 weeks. \$5 late fee if registered after deadline (2 wks of practice with 6 games).

2 **Preschool/School Age Programs** (Preschool P.E., Playgroup): Members - \$30 for the first child and \$15 for each additional child (immediate family only) for 8 weeks. \$40 for Non-members per child for 8 weeks. \$5 late fee if registered after deadline.

**q. PCC Adult Program Fees:**

1. **Sports Fees and Length:** \$250 per team-up to 16 week season

2. **Family Fun Runs and Events:** \$8 for Members \$13 for Non-members. \$5 late fee if registered after deadline.

**r. Youth Sport Association Rental Fees:**

This discounted fee will be extended to local youth sport associations in good IRS 501(c)3 standings. They will be able to reserve half of the gym as long as the request is made 2 weeks in advance.

**Section 2.** All other ordinances approved prior to the passage, approval, and publication or posting of this ordinance which conflict with these provisions are repealed.

**Section 3.** This ordinance is adopted and published in pamphlet form, and shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
