ITEM 9 E

Council member Brookhouser introduced an ordinance numbered and titled as follows: ORDINANCE NO. 1872: AN ORDINANCE OF THE CITY OF PLATTSMOUTH, NEBRASKA TO ESTABLISH FEES FOR CITY SERVICES; TO REPEAL ALL ORDINANCES AND RESOLUTIONS IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

Michael Lennen, Plattsmouth Recreation Director stated that his recommendations for changes to the fee structure for the Plattsmouth Community Center comes after extensive evaluation of the current facility programs and usage. Some of the proposed changes are eliminating the activation fee, adding Youth Programs (initially for indoor soccer) and adding Adult Programs (i.e. Basketball, Volleyball and Indoor Soccer). Lennen stated that before he could make any additional recommendations for changes he would need to do further evaluation and gathering of data.
