Steve Perry, PE, Olmsted & Perry Consulting Engineers Inc. reviewed the 2021 Street Repair and Overlay Project and specified the areas involved. ## ITEM 8 B

Steve Perry and Jim Olmsted, Olmsted & Perry Consulting Engineers Inc. gave a presentation on the 2019 Flood Recovery Project-Water Supply System Replacement. The three alternatives presented were: Relocate the Water Plant to Fourmile Industrial Park; Connect to regional water supplier (M.U.D.); and Flood proof the existing water plant. Mr. Olmsted recommended the M.U.D. Connection alternative as it was best and most cost effective for the City and is a reliable permanent solution. The cost would be \$27,272,680 with FEMA funding 90% (\$24,518,412) through the Directed Relocation Program, with the remaining 10% (\$2,724,268) split between NEMA and the City. The funding of the City's portion (5%) would be SRF Financing over 40 years at 0% interest. Following discussion and numerous questions, Motion by Forrest seconded by Derby to authorize staff and engineers to proceed with the 2019 Flood Recovery Project-Water Supply System Replacement: M.U.D. Water Connection Alternative. ROLL CALL: Yes-Brookhouser, Forrest, Derby, Riese, Clark, Muller, Kerns and Minahan. No-None. Absent-None. Abstain-None. MOTION CARRIED.
