This agreement is structured to provide the engineering services associated with the project from the design through construction phases. The total cost for the New Water Supply System is estimated to be \$27,060,000.00. The proposed fixed engineering fee is \$741,000.00 to complete the 30% Preliminary Design Phase (Design, Schematic layouts, alignments, cost estimates and ROW impacts). The 30% Preliminary Design Phase is estimated to take four months to complete based on a January 3, 2022 issuance of Notice to Proceed. Council discussed contract terms. Following discussion, Motion by Brookhouser seconded by Derby to approve the Engineering Services Agreement with Olmsted & Perry Consulting Engineers Inc. for the City of Plattsmouth's Water Supply System Project and authorize the Notice to Proceed with the Preliminary Engineering 30% Design Services.
