Staff recommends denial of request for vacation of the portion of East Bay Road as it may limit the access and future development of a 56.41 acre parcel east of 3rd Avenue with a single point of access at Oreapolis Road. Roger Schmidt, developer of adjacent property (18840 Webster Blvd.), spoke in favor of the vacation but stated it would be acceptable to him to vacate just county road 3rd Avenue and leave the portion of East Bay Road open. The county's request is for approval of a single resolution and proposed vacation plat for both a portion of East Bay Road and all of county road 3rd Avenue, so the vacation of just county road 3rd Avenue would require an amended/new request from the county.
