Steve Perry PE, Olmsted & Perry Consulting Engineers Inc. reviewed Contractor's Application for Payment No.3 submitted by Steve Harris Construction Inc. for the Vireo Parkway Paving Improvements at the Fourmile Industrial Park (2019 Flood Recovery Project PW#88688-Relocated Wastewater Treatment Facility) in the amount of \$111,609.25. This is a progress payment representing 95% project completion, substantial completion documentation was issued to allow for use of the road. Mr. Perry recommended approval. City Administrator, Emily Bausch, discussed how materials testing and inspections are usually taken care of by the contractor, but with the magnitude of the Wastewater Treatment Plant project it would be better to bring in a Third Party to perform these tests and inspections. Steve Perry confirmed that the Third Party would report directly to the city and their services are eligible for FEMA funds. Motion by Riese seconded by Clark to authorize the solicitation of Request for Qualifications (RFQ) for a Third Party Materials Testing and Special Inspection Services includes special construction phase services in accordance with the International Building Code (IBC) related to construction of the New Wastewater Treatment Plant, Contract 2 2019 Flood Recovery Project PW #88688 – Relocated Wastewater Treatment Facility.
