## ITEM 8 B

Keith Hobson, Strand Associates Project Manager, and Steve Soupir, Strand Associates Project Engineer, discussed the Wastewater treatment plant Contract No. 3. This project will include installation of sewer force main, storm sewer, water main, and concrete work. Six bids were received for this project and Valley Corporation was the lowest bid. Valley Corporation has done work for the City before and Steve Soupir recommends bid award. Emily Bausch, City Administrator, told Council this is just notice of award, the contract will be negotiated and brought before Council at a future meeting. Following discussion, Motion by Forrest seconded by Clark to approve bid award to Valley Corporation for the New Wastewater Treatment Plant Contract No.3 - Wastewater Treatment Plant at the Fourmile Industrial Park Site (2019 Flood Recovery Project PW#88688-Relocated Wastewater Treatment Plant) in the amount of \$17,581,944.49 and authorize the Mayor to execute Notice of Award. ### ITEM 8 C

Keith Hobson, Strand Associates Project Manager, summarized the Strand Associates Service Agreement the City approved in April 2023. This is the second Task Order attached to that agreement and reflects fees associated with supervising the Contract No. 3 Force Main Project. This project has a timeframe of 27 months and will require extensive on-site monitoring and public hearings to inform citizens of the construction timeline along Lincoln Ave. Keith recommends approval. Motion by Brookhouser seconded by Minahan to approve Task Order No. 2 to the Construction Phase Engineering Services Master Agreement with Strand Associates (2019 Flood Recovery Project #88688- Relocated Wastewater Treatment Facility) in the amount of \$2,700,000.00 and authorize the Mayor to execute Task Order No. 2. ## ITEM 8 D

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., informed Council that three bids were received for the 2023 Concrete Repair Project and VanWinkle dba Lakeview Construction was the lowest bidder. Steve is confident Lakeview Construction can handle this project because of previous work they have done for the City, he recommends approval. Motion by Muller seconded by Brookhouser to approve bid award to VanWinkle Construction Services dba Lakeview Construction for the 2023 PC Concrete Street Repair Project in the amount of \$140,373.00 and authorize the Mayor to execute the Agreement. ROLL CALL: Yes-Forrest, Clark, Kerns, Graham, Muller, Minahan, Riese and Brookhouser. No-None. Absent-None. Abstain-None. MOTION CARRIED.

## ITEM 8 E

Council member Kerns stated he would be abstaining from any discussion or action on ITEM 8 E due to a conflict of interest.

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., told council only one bid was received for the Avenue A and 8<sup>th</sup> Street project. Steve reminded Council that this is a cost share project with the City funding 60% and 40% funded by the Old Historic High School, First Baptist School and the Plattsmouth Early Childhood Center when they decide to hook onto the new system. Emily Bausch, City Administrator, said the City will seek SRF or Economic Development Funds for this project. Following discussion, Motion by Brookhouser seconded by Riese to approve bid award to Kerns Excavating Co. Inc. for the Avenue A and 8<sup>th</sup> Street South Sanitary Sewer Project in the amount of \$164,948.60 and authorize the Mayor to execute the Agreement. # ITEM 8 F

Council member Kerns stated he would be abstaining from any discussion or action on ITEM 8 F due to a conflict of interest.

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., reminded Council that this project was originally bid in 2021 but was postponed due to FEMA funds not being available. Now with FEMA funding available the project was rebid and of the three bids Kerns Excavating was the lower bidder. Steve anticipates traffic issues during construction but with two points of access to the area and coordinating with residents he is hoping the inconvenience can be mitigated. Steve recommends approval and estimates a November 2023 completion date. Following discussion, Motion by Brookhouser seconded by Minahan to approve bid award to Kerns Excavating Co Inc. for the Oakmont Drive Water Main Improvements (2019 Flood Recovery Alternate Project) in the amount of \$433,162.00 and authorize the Mayor to execute the Agreement. ## ITEM 8 G

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., Stated that these easements needed to be updated since Replat V of Fourmile Industrial Park was approved by Council at the May 15, 2023 meeting. These new easements will not impact the new Wastewater Treatment Plant. Stephen Q. Preston, City Attorney, reminded Council they approved vacating the original undefined blanket easements with Ordinance No. 2005 to allow for these specific easements to be negotiated. Following discussion, Motion by Brookhouser seconded by Muller to approve Partial Release and Grant of Right-of-Way with Magellan Pipeline Company, LP, and authorize the Mayor to execute the Agreement. ROLL CALL: Yes-Clark, Riese, Forrest, Minahan, Graham, Kerns, Brookhouser and Muller. No-None. Absent-None. Abstain-None. MOTION CARRIED.

# ITEM 8 H

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., stated the City has negotiated with NPPD to provide temporary overhead electrical service for Hawkins Construction while they build the new Wastewater treatment plant. The three overhead spans will become part of the permanent service to the Wastewater plant when it is finished. Emily Bausch, City Administrator, informed council that this cost share is part of the City's power purchase agreement with NPPD. Following discussion, Motion by Kerns seconded by Graham to approve Partial Primary Electric Extension of Permanent Service with Nebraska Public Power District located along Vireo Parkway for the new Wastewater Treatment Plant located at 13949 Vireo Parkway and authorize payment of the estimated cost of \$19,471 (2019 Flood Recovery Project #88688-Relocated Wastewater Treatment Facility) and authorize the Mayor to execute documents pertinent to the project. Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., stated Task Order 29 was approved on March 15, 2021 but FEMA funds were not released and two of the projects have been scaled back due to floodway issues. Amendment No. 1 reflects the revised scope of work for the smaller projects. Following discussion, Motion by Brookhouser seconded by Riese to approve Amendment No. 1 to Task Order No. 29 for the City of Plattsmouth's 2019 Flood Recovery Alternate Project revised Scope of Work and a Not to Exceed Ceiling Price of \$96,350.00 for Design Phase Services and authorize the Mayor to execute Amendment No. 1 to Task Order No. 29. ### ITEM 8 J

Steve Soupir, Strand Associates Project Engineer, said this project will address critical repairs to piping and manholes that were discovered when the Sewer lines were televised for the Force Main Project. This project will piggyback Contract No. 3 Force Main Project so Lincoln Ave. will only have to be torn up once. Of the two bids received Valley Corporation was the lowest, they were also the lowest bidder on the Contract No. 3 Force Main Project. Steve says it is ideal that both contracts are done by the same company, so coordination of the projects won't be an issue. Emily Bausch, City Administrator, made Council aware that this project will be funded with SRF long term financing. Emily also said this is just notice of award, the contract will be negotiated and brought before Council at a future meeting. Following discussion, Motion by Clark seconded by Forrest to approve bid award to Valley Corporation for the Lincoln Avenue Sanitary Sewer Repair Project in the amount of \$683,459.83 and authorize the Mayor to execute Notice of Award. The agreement is before council because they did not meet insurance requirements but have submitted an alternate insurance declaration page. Stephen Q. Preston, City Attorney, clarified to council that they have the option to approve the original agreement and insurance or approve the agreement with the alternate insurance provided in the Council packet for this meeting. Emily Bausch, City Administrator, introduced a Resolution numbered and titled as follows: RESOLUTION NO. 23-003: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF PLATTSMOUTH, NEBRASKA, TO RECEIVE THE PAY OFF A CDBG LOAN FOR

PROPERTY LOCATED AT 1719 VALLEY STREET, PLATTSMOUTH, NEBRASKA; TO REMIT THE SAME TO THE NDED AS PROGRAM INCOME; AND TO AUTHORIZE THE CITY ATTORNEY, AS TRUSTEE, TO EXECUTE A DEED OF RECONVEYANCE AND SUCH OTHER DOCUMENTS AS MAY BE NECESSARY TO EFFECT THE FOREGOING

Emily informed Council that this Resolution is completing a Community Development Block Grant (CDBG) payment that was issued in 2014 for a property rehabilitation project.
