#### ITEM 8 D

Jim Olmsted, Olmsted & Perry Engineering, reviewed with council the water supply studies that were done in the years leading up to 2019. Each study presented three courses of action with hook-up to Metropolitan Utilities District (MUD) being the most cost effective and sustainable. After the 2019 flood the study was updated for FEMA flood recovery project #88690. Jim Olmsted presented the 30% design for MUD hook-up and John Gade and Keith Hobson, Fox Strand Engineering, lead a presentation and discussion on the proposed project. There will be many moving pieces for this project ranging from easement acquisition, boring under the Platte River, railroad & Hwy 75 crossings and reconstruction of part of Ave B. The estimated completion date is May 2027. Following discussion, NO ACTION TAKEN.
