**I hereby understand and accept the terms and conditions relative to the issuance of the “Sidewalk Sales” permit, and by signing below, I acknowledge the receipt of a copy of the Plattsmouth Municipal Code Article XII, Section 5-1204 and Resolution No. 21-009 pertaining to Temporary Right-Of-Way to Conduct Outdoor Retail, as well as all the additional requirements promulgated herein:**

**I understand it shall be my duty as the permit holder, and as a condition of the permit, to:**

- 1. Comply with all requirements defined within the Plattsmouth Municipal Code Article XII, Section 5-1204. A certificate of insurance showing the applicant has acquired public liability, food products liability and property damage insurance in the sum of not less than five hundred thousand dollars (\$500,000.00) combined single limit, which insurance may not be cancelled prior to the expiration of the permit without providing thirty (30) days written notice to the city. The City of Plattsmouth, Nebraska, shall be name a secondary insured party on such policy.**
- 2. The License shall be visibly displayed in the Licensee’s CBD Property.**

**I understand that failure to adhere to all conditions imposed in the permit may result in revocation of the permit.**
