

**ORDINANCE NO. 2029**

**AN ORDINANCE OF THE CITY OF PLATTSMOUTH, NEBRASKA TO ESTABLISH FEES FOR CITY SERVICES; TO REPEAL ALL ORDINANCES AND RESOLUTIONS IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.**

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA:

**Section 1:** The City Council of the City of Plattsmouth has determined that the fee structure for services and products provided by the City shall be revised as follows (all rates subject to 7% sales tax):

**Military Discounts:** Retired and active military will receive a 10% discount on all memberships and a \$1 discount for daily admission. Proper ID must be presented for discount.

Wellness Only Memberships only have access to the upstairs fitness area and walking track.

Aquatics Only Members only have access to the pool and aquatic classes.

All other memberships have access to the entire building, Group X classes, Cycling classes and Aquatics classes as long as their age permits entry.

C Grandparents Summer Pass: Grandparents may add up to 3 grandchildren to their Active Membership during summer break (from last day of school until beginning of school based on the Plattsmouth Community School District calendar). Membership must be maintained during the pass period and a grandparent is required to be in the facility with the child.

**Sports Fees and Length:** \$250.00 per team-up to 16-week season

**Family Fun Runs and Events:** \$8.00 for Members \$13.00 for Non-members. \$5.00 late fee if registered after deadline.

R Youth Sport Association Rental Fees:

This discounted fee will be extended to local youth sport associations in good IRS 501(c)3 standings. They will be able to reserve half of the gym if the request is made 2 weeks in advance.

- i. Basketball/Volleyball/Soccer, etc. – Free for members and \$2.00 for non-members for 1 hour
- ii. Batting Cage - \$15.00 per hour per team. Must reserve at least 10 hours to receive discount
- iii. Baseball/Softball/Soccer Fields

**Use of fields for a season shall require a license agreement. With a license agreement, there shall be no fees for field use. Organizations with a license agreement shall have a priority for scheduling.**

Other occasional use for which scheduling field usage is necessary, fees will be:

- 1. Adult Men’s and Women’s softball (no lights) \$100.00 per team
- 2. Adult Men’s and Women’s softball (with lights) \$125.00 per team
- 3. Non-Local youth organizations (no lights) \$100.00 per team

- 5. Non-Local youth organization tournaments (with lights):  
\$125.00 per field per tournament (250.00 deposit).

Note: Tournaments consist of not more than two (2) days with field(s) set up by City prior to event start  
Note: Local shall be defined as within Plattsmouth and Conestoga School Districts
