PLATTSMOUTH CITY COUNCIL November 7, 2011

A meeting of the City Council of the City of Plattsmouth, Nebraska was convened in open and public session at 7:00 o'clock p.m. on November 7, 2011 at City Hall in Plattsmouth Nebraska. Present were Mayor Michael C. Bowman and Council Members: John Porter, Terry Kerns, Terry D. Tilson, Steve Riese, Pat Dugan, Art Tesarek and Doug Derby. Council Members Absent: None. ITEM 5-CITIZEN DELEGATION

Lee Larsen, 20113 72nd Street, Plattsmouth, Nebraska, addressed the Mayor and Council seeking clarification regarding how bids and payment for repairs of damage to his building at 419 Main Street which are alleged to have been sustained as a result of the construction on Main Street. ITEM 10 – UNFINISHED BUSINESS

ITEM 10 A

Pursuant to publication, the Mayor opened the public hearing at 7:10 p.m. with regard to Receipt of evidence that the Mayor and City Council will subsequently consider when determining whether to approve or deny the renewal of two mobile home licenses, to wit: Hill City Mobile Home Park and HiVue Mobile Home Park, both owned and operated by Three Parks, L.L.C. The Mayor and City Council will receive evidence related to the existence of conditions which would constitute the following ordinance violations:

3-602(3): Filthy, littered or trash-covered cellars, houseyards, barn-yards, stable-yards, factory-yards, mill yards, vacant areas in rear of stores, granaries, vacant lots, houses, buildings or premises.

3-602(6): Tin cans, bottles, glass, cans, ashes, small pieces of scrap iron, wire metal articles, bric-a-brac, broken stone or cement, broken crockery, broken glass, broken plaster, and all trash or abandoned material, unless the same be kept in covered bins or galvanized iron receptacles.

3-602(7): Trash, litter, rags, accumulations of barrels, boxes, crates, packing crates, mattresses, bedding, packing material, lumber not neatly piled, scrap iron, tin or other metal not neatly piled, old automobiles or parts thereof, or any other waste materials when any of said articles or materials create a condition in which flies or rats may breed or multiply, or which may be a fire danger or which are so unsightly as to depreciate property

values in the vicinity thereof.

3-602(8): Any unsightly building, billboard, or other structure, or any old, abandoned or partially destroyed building or structure or any building or structure commenced and left unfinished, which said buildings, billboards or other structures are either a fire hazard, a menace to the public health or safety, or are so unsightly as to depreciate the value of property in the vicinity thereof.

Kevin Larson, City Inspector, presented evidence of the following: Four points in hearing notice: Filthy, littered or trash-covered yards; Trash not properly contained; Trash creating a dangerous condition or devaluing the property; and Unsightly/destroyed/dangerous building:

1 - Unit #16 at HiVue being demolished.

Safety has been the biggest concern at Hill City and HiVue Trailer courts, due primarily to the condition of some of the trailers.

2 – Unit #16 at HiVue site cleared.

Unsafe units with broken windows, unsanitary conditions, unsecured vacant units, and unsightly, trash-filled sites went un-cleaned.

3 – Unit #105 HiVue being demolished.

An aggressive demolition and debris removal program by the owner is correcting this situation.

- 4 Unit #105 HiVue site cleared. In the last year, ten substandard units have either been moved out or demolished at the Hill City and HiVue Mobile Home Parks. Another six were either moved or demolished during the previous year.
- 5 Road repair at Hill City.

Crews have also cleared accumulated debris from trailer spaces and trimmed trees.

- 6 Hill City road repair complete.
- 7 Site #105 HiVue to be skirted.

Skirting is being replaced on some of the remaining mobile homes.

8 – Warning sign posted by resident to cat owners at HiVue.

Tenants at Hill City and HiVue have been provided copies of the new park rules.

9 – Site #174 HiVue final cleaning after unit removed.

A garbage truck has been purchased by Three Parks and is being used for removing debris. Hill City and HiVue are now being managed out of the Bellevue office.

10 – Empty unit spaces at Hill City.

Mr. Chad Menke addressed the Mayor and City Council and said his intentions are to install newer units once maintenance and improvement projects have been completed.

Police Chief, Steve Rathman, presented evidence in regard to City Ordinance nuisance violations in the two mobile home parks: Unsafe conditions-some so bad you can't even get to the front door; weeds, grass and tires; Ferrell cats at HiVue – being fed by tenants but are not vaccinated or licensed.

Ron Bertsch, 828 Main Street, Plattsmouth, NE-owner of 7 mobile homes located in both parks, reported that the code violations were real, but he had confidence that the park owner will address the violations and that based on this confidence he had recently purchased 2 additional mobile homes. Bertsch urged the council to move forward with a plan in conjunction with the owner of the parks to take care of the issues. Mr. Bertsch stated that he felt the park owner could achieve the goals.

Joe Morehead spoke on behalf of his daughter and her fiancé who recently purchased a mobile home in one of the parks, and stated that the park owner had made improvements.

Chad Menke, owner of the parks, described improvements made over the years and stated that in the last two years his time has been occupied by other issues but assured the council that improvements will continue.

Larry Thompson, 2902 Hancock St #88, Bellevue, NE, stated that he has worked at the parks since May 2011, and that they are trying to take care of the parks and to get the tenants to do the same. Mr. Thompson asked the council to give the owner another year to clean up the parks. He stated that the owner had made tremendous progress and assured the council that it would continue.

Mike Oakley, 2902 Hancock St #184, Bellevue, NE, stated that he works for the owner and that they are working very hard to clean up the parks but that it would take time.

Shirley Stipe, 1023 N. 9th St #14, Plattsmouth, NE, stated that she has always kept her lot clean and in the last three weeks the owner had torn down a trailer next door to hers and that it looks very nice and with a little time the owner will clean up the park she lives in.

Kathy Bechler, 1023 N. 9th St #61, Plattsmouth, NE, stated that the owner has been working on the problem conditions and the owner is making the park much better.

Henry Guynn, 1023 N. 9th St #11, Plattsmouth, NE stated that he has lived in his current home for 16 years and knows there have been problems but the owner is improving the park and that he likes living in HiVue Mobile Home Park.

Terry Stoll, 1023 N. 9th St., Plattsmouth, NE stated that in 1984 she moved to HiVue and in 1998 purchased a new mobile home. She further stated that sometimes people are a little slow but she can see improvement. She also believes that the tenants are also improving their lots. She believes the owner will continue to improve the conditions.

Nancy Black, 1023 N. 9th St., Plattsmouth, NE stated she has lived at HiVue for 45 years and improvements have been made, that her trailer is too old to move, and that the owner has done a lot of work to the parks.

Jerry Priessnitz, 1023 No. 9th St #44, Plattsmouth, NE has seen a number of improvements in the park and that the park could be beautiful. He stated that he has been dealing with a tree problem and that the owner has agreed to take care of it. He stated that he believes that if management does its part, everybody else will follow.

Mayor Bowman closed the Public Hearing at 7:43 p.m.

ITEM 10 B

Council Member Tilson distributed handouts outlining the timeline of the Mobile Home Licensure status within the City. Tilson proposed the City surrender its "Certificate of Exemption" and return the inspection/license process to the State. The City could approve a limited license of 6 months (through June 2012) for HiVue and Hill City with monthly inspections and allow the mobile home court owner to apply for a state license in June 2012 to go through December 2012. If we do surrender our Certificate of Exemption we would also need to contact all mobile home court owners within the city to file for a State License and Inspection prior to December 31, 2012. After further discussion, motion by Porter to issue a one year license for HiVue Mobile Home Park and Hill City Mobile Home Park. With lack of a second, Porter's motion died. Council Member Riese stated that he liked the conditional/probation 6 month license with a detailed list of items to be addressed during the 6 months to bring the mobile home park in to compliance. After further discussion, motion by Dugan to lay over items 10 B and 10 C to the next regularly scheduled meeting and create a detailed list of items to be addressed for each item and then the council will reconsider. Said motion was seconded by Kerns. ROLL CALL: Yes-Tilson, Riese, Dugan, Tesarek, Derby, Kerns and Brookhouser. No-Porter. Absent-None. Abstain-None. MOTION CARRIED.

ITEM 10 C

This item was included in the motion made for Item 10 B.

ITEM 10 D

Council Member Riese asked for clarification of the agenda item. City Administrator Erv Portis stated that the request is to limit traffic to southbound one way in the north/south alley east of 3rd Street between Avenue A and Main Street. Motion by Dugan, seconded by Riese to direct the City Attorney to prepare a resolution establishing a one way alley southbound east of 3rd Street between Avenue A and Main Street. ROLL CALL: Yes-Brookhouser, Tilson, Riese, Dugan, Tesarek, Derby and Kerns. No-Porter. Absent-None. Abstain-None. MOTION CARRIED.

ITEM 10 E

Motion by Riese, seconded by Dugan that the statutory rule requiring reading an ordinance on three different days be suspended and that Ordinance No. 1838 be adopted on third and final reading by title only. ROLL CALL: Yes-Tesarek, Derby, Porter, Kerns, Brookhouser, Tilson, Riese and

Dugan. No-None. Absent-None. Abstain-None. MOTION CARRIED. City Attorney Roger Johnson read Ordinance No. 1838 in to the record by title only.

ITEM 10 F

Chris Koenig, HDR Engineering Inc. reviewed the Flood Control Study, the Flood Damage Assessment and the Vulnerability and Mitigation Plan which were all prepared by HDR Engineering and Olmsted & Perry Consulting Inc as subconsultants. Koenig stated that it is a work in progress, there is a lot of damage from the flood and a lot of decisions to be made. Koenig pointed out that there are two stages: Damage Assessment and then the Mitigation Plan and that funding is based on actual cost. The Path Forward will be: Preliminary and final design of the 24 inch trunk sewer; Bid documents for Wastewater Treatment Plant cleanup; and continue working with NEMA/FEMA on decisions on repair and mitigation.
