Motion by Dugan, seconded by Riese to approve third (3rd) and final reading of ORDINANCE NO. 1861 by title only. ROLL CALL: Yes-Brookhouser, Riese, Dugan, Wiemer, Derby, Porter and Kerns. No-None. Absent-Tilson. Abstain-None. MOTION CARRIED. Said ordinance was read in to the record by title only.

ITEM 8 B

Steve Perry, Olmsted & Perry Consulting Engineers Inc. reviewed the bids received May 30, 2013 for the City Hall Re-Roofing and Repair Project and recommended Ciaccio Roofing Corp., the low bidder, which also has a 20 year warranty. Motion by Kerns, seconded by Riese to approve award of construction contract to Ciaacio Roofing Corp. for the City Hall Re-Roofing and Repair Project and authorize the Mayor to execute the contract. After discussion, ROLL CALL: Yes-Riese, Dugan, Wiemer, Derby, Porter, Kerns and Brookhouser. No-None. Absent-Tilson. Abstain-None. MOTION CARRIED.

ITEM 8 C

Motion by Riese, seconded by Porter to approve Pay Application No. 2 submitted by Neuvirth Construction Inc. for Well No. 8 Site Improvements in the amount of \$55,738.80 and authorize the Mayor to execute Pay Application No. 2. ROLL CALL: Yes-Dugan, Wiemer, Derby, Porter,

Kerns, Brookhouser and Riese. No-None. Absent-Tilson. Abstain-None. MOTION CARRIED.

ITEM 9 – NEW BUSINESS

ITEM 9 A

Pursuant to publication Mayor Bowman opened a public hearing at 7:25 p.m. with regard to a request for a kennel special use permit in a RR (Rural Residential) zoning district by Tom Harter on property located at 17705 Pioneer Trail, Plattsmouth, legally described as 01-12-13 Swallow Hills Estates Lot 39, SW1/4 06-12-14 & NW1/4 07-12-14, 9.45~ acres. Tom Harter, 17705 Pioneer Trail (applicant) reviewed measures to secure dogs and they are show dogs and family pets. Was informed by Kevin Larson, Inspector for City of Plattsmouth that he would need to apply for a special use permit. Harter stated he has 5 dogs-3 mastiffs. Please consider the application; Karen Campbell, 17668 Pioneer Trail reviewed incident of being surrounded by dogs (4-6 mastiffs) and presented documentation. Safety starts with recognition of the danger of pack behavior; Sam Distefano, 18006 Pioneer Trail referenced owner carelessness and expressed concern for public safety; Barbara Harter, 17705 Pioneer Trail stated they have 4 mastiffs-one had cancer and had to be put down. They are hobby breeders not commercial and the dogs are devoted to the family. Don't plan on getting any more dogs; Jody Distefano, 18006 Pioneer Trail presented a statement of objection from a neighbor, a sheriff's report, Sue Baker's report and a report on pack behavior. Is a dangerous and horrifying situation and is a safety issue; Jann Bergerson, 17937 Pioneer Trail referenced a petition that over ½ the neighborhood signed. There is a pack mentality and safety issues. No service from City for animal control. Asked council not to grant but if do approve ask for adequate liability insurance from the Harters; Mike Schuldt, 17691 Pioneer trail stated his only concern is with the commercial kennel-people can and do change their minds. Does not support unrestricted permit but wants the Harters to keep all their dogs. Is comfortable with restrictions Harter has offered; Joe Ehlers, 413 Whitman Ave. felt Harters are responsible. He was a dog breeder. Campbell hit the dogs with a stick and they didn't bite. Hopes council will grant; Patty Trouba, 17633 Pioneer Trail requested council not grant the permit. Referenced the impact on property values and safety. Presented an exhibit for the record; Bruce Dolan, 17820 Pioneer Trail is opposed to the permit, had a nephew who had half his face ripped off by a nice dog. In Wyoming packs of dogs chase antelope; Barry Trouba, 17633 Pioneer Trail asked council to deny kennel permit. There will be safety issues and noise issues. City does not take responsibility for animal control. Referenced a court case regarding Lincoln and covenants; Erv Portis, City Administrator stated that the City of Plattsmouth Animal Control has no jurisdiction outside the city limits; Janet McCartney, 19705 Shoreline Circle, Cass County Commissioner stated that the Cass County Sheriff must control vicious dog concerns; Heather Anschutz, 17943 Pioneer Trail presented and reviewed a factual timeline re: Opposition to Tom Harter's Application for a Special Use Permit for a Commercial Kennel Permit. Harters are not law abiding and they had an opportunity to have more than two dogs and they blew it. Website and face book page states size does matter-Mastiff's have a strong bite, double the strength of a pit bull. Breeding cannot be prevented but 2 dogs are plenty and pack behavior needs to be prevented; Karen Adkins, 17990 Pioneer Trail was asked to sign petition against the permit but the information that was given to them was untruthful and exaggerations so they were not willing to sign petition. Stated the Harter's apologized for the emotional e-mails and they have done what they could to address the mistakes. Harters not asking for a commercial kennel permit. In 18 yrs. have had 3 litters of puppies. The covenants are broken

so wishes they would go away or everyone follow. In support of application; David Campbell, 17668 Pioneer Trail objected to approval of application because dogs are big, powerful, occasionally out of control and Harter's have refused to accept responsibility; Tim Adkins, 17990 Pioneer Trail stated that he feels there are two issues: opposition to kennel and fear of large dogs. Harters want to keep the dogs they have and they have taken measures to control. Adjacent neighbors are not opposed-recommend approval with restrictions; Mark Bergerson, 17937 Pioneer Trail reminded the council of the past disrespect for the law, the original request was for 30 dogs and commercial breeding. Bergerson is against approval of the application for kennel permit; Kevin Larson, City Inspector entered documents, a memorandum dated 5-8-2013 and The Land Development Ordinance for the City of Plattsmouth-August 2006. No one else spoke on the issue. Mayor Bowman closed the public hearing at 8:27p.m.

Mayor Bowman indicated the need for the council to go in to closed session to protect the public interest with regard to legal contractual and negotiation matters related to the Plattsmouth Rural Fire Board Interlocal Agreement. 8:29 p.m. Motion by Dugan, seconded by Brookhouser to convene to Closed Session to protect the public interest with regard to legal contractual and negotiation matters related to the Plattsmouth Rural Fire Board Interlocal Agreement. ROLL CALL: Yes-Wiemer, Derby, Porter, Kerns, Brookhouser, Riese and Dugan. No-None. Absent-Tilson. Abstain-None. MOTION CARRIED. Mayor Bowman again stated that the Closed Session was to protect the public interest with regard to legal contractual and negotiation matters related to the Plattsmouth Rural Fire Board Interlocal Agreement.

9:26 p.m. Motion by Riese, seconded by Dugan to reconvene in to regular session. On a voice vote, MOTION CARRIED.
