ITEM 8 A

Pursuant to publication, Mayor Bowman opened a public hearing at 7:22 p.m. in regard to a request for rezoning by Schmidt Transportation Inc. from AG (Agricultural) to GC/MU (General Commercial/Mixed Use) on property located south of 108 East Bay Road, legally described as Lots 1 and 2 Schmidts Commercial, being a platting of part of the West ½ of the Northwest ¼ of Section 1 and part of Lots 6 and 14 in the East ½ of the Northeast ¼ of Section 2, Township 12 North, Range 13 East of the 6th P.M., Cass County, Nebraska. Bill Reinsch, 545 Main Street, Plattsmouth NE, Attorney for Schmidt Transportation reviewed the Compressed Natural Gas (CNG) project. Reinsch stated that the first lot would be the fast fill station, the second lot would be the parking with the time fill and the balance of the property would remain agriculture land. Joe Foley, project engineer with Lamp Rynearson, 14710 West Dodge Road, Omaha NE, reviewed the changes made as a result of the Plattsmouth Planning Commission recommendations (entrances, traffic analysis and lighting). Harriett D. Holman, 415 Oreapolis Road, Plattsmouth NE stated that she owns property to the east of the above mentioned property. Holman stated that the project is in the Flood Plain and that safety doesn't seem to be a concern. Holman saw no reason for the project and questioned why it was not left as valuable farm ground. Holman asked the Council to deny the request. Roger Schmidt, 19613 Gladys Drive, Plattsmouth, NE applicant requesting rezoning introduced himself and was available for questions. Mayor Bowman and Council Members questioned Mr. Schmidt with regard to increase of jobs, security, fire coverage, lighting, fast versus slow fill, odor of the Compressed Natural Gas and also the advantages of fueling with Compressed Natural Gas. No one else spoke. Mayor Bowman closed the public hearing at 7:50 p.m.
