### ITEM 8-UNFINISHED BUSINESS

#### ITEM 8 A

Erv Portis, City Administrator reviewed the Nebraska Department of Roads request for the city to accept a lump sum payment for the entire amount in lieu of performing the obligations agreed upon in the U.S. Highway 34 Relinquishment Agreement adopted by the Nebraska Department of Roads and City of Plattsmouth November 19, 2007 and stated that additional improvements are necessary. If the City does not accept the lump sum payment Nebraska Department of Roads will only do heavy patch and overlay on the roadway, nothing else. Steve Perry, Olmsted & Perry Consulting Engineers Inc. stated that after assessing the project area he would estimate \$1.1 to \$1.3 million to do the project and that he did allow for conditions outside the parameters of the original agreement so he felt that even with unknowns that the project would not exceed the \$1.3 million. Perry indicated that the work could be done in phases. Current condition of the roadway and state standards were reviewed. It was discussed that any future agreements with the Nebraska Department of Roads need to be reviewed with situations at least 10 years down the road in mind. Motion by Kerns, seconded by Porter to approve the amended agreement. After further discussion, Kerns amended his motion: Request the Nebraska Department of Roads to draw up an amendment, a lump sum payment of \$988,000.00 to the City of Plattsmouth in lieu of the Nebraska Department of Roads performing the obligations agreed upon, to the U. S. Highway 34 Relinquishment Agreement for council consideration. Said amended motion was seconded by Porter. ROLL CALL: Yes-Brookhouser, Tilson, Riese, Dugan, Wiemer, Derby, Porter and Kerns. No-None. Absent-None. Abstain-None. MOTION CARRIED.

#### ITEM 8 B

Motion by Brookhouser, seconded by Tilson to approve Change Order Project #07 in Plattsmouth's City Wide Housing Rehabilitation Program (12-HO-6046) in the amount of \$2,000.00 for a final project cost of \$26,995.00. Following discussion, ROLL CALL: Yes-Dugan, Wiemer, Derby, Porter, Kerns, Brookhouser, Tilson and Riese. No-None. Absent-None. Abstain-None. MOTION CARRIED.

#### ITEM 9 A

Motion by Riese, seconded by Wiemer to recommend repairing the vandalized Columbarium Wall at Oak Hill Cemetery with the 12 in. x 12 in. niches and submit the recommendation to the insurance company. The 4 in. x 4 in. niches versus the 12 in. x 12 in. niches were discussed. Removing the damaged area and not doing any repairs was discussed. Utilizing the wall for another purpose was also considered. Riese withdrew his motion and Wiemer withdrew her second. The Council recommends removing the damaged area, do no repairs and consider utilizing the wall for another purpose. NO ACTION TAKEN.
