ITEM 8 A

Pursuant to publication, Mayor Lambert opened a public hearing at 7:04 p.m. to Hear public comment regarding a Rezoning Application submitted by Wiles Development LLC requesting a zoning change from RR (Rural Residential) to RR with a Mixed Use Overlay on property located east of Highway 75 at 18003 Club View Road, legally described as a tract of land being part of the Northwest ½ of the Northwest ¼ and part of the Southwest ¼ of the Northwest ¼ of Section

12, Township 12 North, Range 13 East of the 6th P.M., Cass County, Nebraska (said tract of land contains an area of 1,791,903 square feet or 41.136 acres, more or less). Jerry Slusky, 8712 W. Dodge Road, Omaha, NE-Real Estate Attorney for the Developer (Wiles Development, LLC): gave an overview of Phase I and Phase II of the project and reviewed the traffic analysis for the proposed project area; Slusky told Council that all proposed Phase 1 uses are currently permitted uses per Table 4.1 of the City's zoning ordinance; Al Povondra, 5060 Dodge Street, Omaha, NE-Carlson West Povondra: Reviewed Phase I and Phase II of the project in detail; Povondra told Council that all proposed Phase 1 uses are currently permitted uses per Table 4.1 of the City's zoning ordinance; Silas Clarke, 4358 Pacific Street, Omaha, NE-General Manager Wiles Hops Facility: Reviewed the process for harvesting the hops; Kyle Haase, 11919 Mill Valley Road, Omaha NE-E & A Consulting Group: Reviewed the US Hwy 75 and Club View Drive Traffic Impact Study, parking, and the water and sewer systems; David Stuart, 17904 Hwy 75, Plattsmouth, NE: Voiced many concerns from noise to safety to fire protection; Bob Felthousen, 17810 Hwy 75, Plattsmouth, NE: Not opposed to the project just some concepts he doesn't care for such as noise and traffic safety; Janet McCartney, 2825 Lakeside Drive, Plattsmouth, NE: present in the capacity of a citizen and also a Cass County Commissioner-in favor of the project and Club View Drive is a county road that will be maintained; Terry Walsh, 18111 Peterson Road, Plattsmouth, NE: Questioned the odor from drying hops and Hwy 73/75 Expressway standards and voiced concerns about traffic safety; Dawn Faircloth-Quinn, 18110 Peterson Road, Plattsmouth, NE: Questioned the odor generated from the drying of the hops once all planned areas are planted; Doug Knight, 18001 Peterson Road, Plattsmouth, NE: bought property for the views and is concerned what views he will have after the project is complete and also concerned how the project will impact property values; Bruce and Annette Wiles, 19515 Watersedge Circle, Plattsmouth, NE-Developers: Stated that they felt the Hops Facility was the best use of the property and want to be good neighbors and welcome questions, comments and concerns. Stated the harvest is August/September (about 3 weeks). A drip irrigation system is used so the water usage will be less than when the Country Club occupied the property. With no one else present to speak, Mayor Lambert closed the public hearing at 8:06 p.m.

Motion by Wiemer, seconded by Porter to approve first reading of ORDINANCE NO. 1906 by title only. Following discussion regarding the Traffic Study, future development and the deceleration lane, ROLL CALL: Yes-Brookhouser, Dugan, Porter, Derby, Tilson, Kerns,

Wiemer and Riese. No-None. Absent-None. Abstain-None. MOTION CARRIED. City Attorney Stephen Q. Preston read ORDINANCE NO. 1906 in to the record by title only.

ITEM 9-NEW BUSINESS

ITEM 9 A

Mayor Lambert read RESOLUTION NO. 16-001 by title only. Mayor Lambert told Council and the audience that no public hearing was required or scheduled, but asked if there was anyone in the audience who would like to comment on RESOLUTION NO. 16-001, which the council would be considering action on. Steve Willey, President of Westside Development-indicated that he was unaware of the project plans for 1st Avenue/Hwy 75 intersection until recently and expressed concerns regarding timing, safety and the economic impact. Willey questioned the restrictions at the intersection of 1st Avenue and Hwy 75. Willey asked that the council delay any action on this item until concerns are addressed as he has lots to say and would appreciate the opportunity. Raymond Wicks, First Baptist Church-Would like to see the speed limit reduced. Wicks stated that the State Permit he obtained was very clear. Doug Keeler, 2709 1st Avenue, Plattsmouth, NE-Felt that no left access would cause traffic issues and he is opposed to council making a decision tonight without considering other options. Burton VanDenburg, 2203 Hwy 66, Plattsmouth, NE-Has concerns: Curious as to impacting the city; worried there will be more traffic using the FOE 365 intersection (Hwy 75/Avenue B); effect on response time for Emergency Vehicles; and the economic impact. Tim Weander, Nebraska Department of Roads District Engineer, Omaha-Reviewed the timeline and background for this project (Project No. S-75-2(1072); reviewed/explained the spacing for access for Expressways; spacing is for efficiency of traffic movement and the current movement is the safest for this situation. Most important when considering access is safety and spacing. Ervin Portis, City Administrator-presented documents dating back to 2005 (specifically Westside TIF Documents) referencing this specific traffic/intersection issue.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA APPROVING, AND AUTHORIZING THE MAYOR TO EXECUTE, AN AGREEMENT WITH THE NEBRASKA DEPARTMENT OF ROADS (NDOR) FOR THE PURPOSE OF THE CITY'S FINANCIAL PARTICIPATION IN IMPROVEMENTS TO STATE HIGHWAY US-34/US-75 (HWY 34/75) CONSISTING OF GRADING, CONCRETE PAVEMENT/SURFACING, CULVERTS, BRIDGES GUARDRAIL, LIGHTING, AND TRAFFIC SIGNALS BEGINNING AT THE SOUTH CORPORATE LIMITS (R.P. 378+25); LEAVING THE CORPORATE LIMITS AT R.P. 378+30; REENTERING CORPORATE LIMITS AT R.P. 379+18 AND EXTENDING NORTH TO R.P. 72+81; AND FOR THE PURPOSE OF ACCEPTING THE DUTIES SET FORTH IN THE AGREEMENT, PROJECT NO. WHEREAS, the Mayor and City Council find that the improvements are necessary for the safety and welfare of the motoring community; and

WHEREAS, the Mayor and City Council find that the improvements are vital to the future economic growth and development of the City as well as the region beyond, and that such improvements to Hwy US-34/US-75 will greatly benefit the City of Plattsmouth in its business development and transportation needs.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Plattsmouth, Nebraska, that the Agreement with NDOR for Project No. S-75-2(1072) CN 21209, Murray – Plattsmouth is approved and the Mayor is hereby authorized to execute said Agreement.

Mayor Lambert read RESOLUTION NO. 16-002 by title only.

Roger K. Johnson, Legal Counsel for the Plattsmouth Airport Authority presented a photo of the airport and pointed out the proposed improvements if the Council were to approve RESOLUTION NO. 16-002. Diane Hofer, Olson & Associates, Lincoln NE was present and has been working with the Plattsmouth Airport Authority with design and prioritization. Ms. Hofer stated that the coordination of the Federal, State and Local monies is critical and this is the last piece to secure all funding. Roger Johnson also stated that if these improvements were not completed that future State and Federal funds (grants) would be in jeopardy. Essentially, the

proposed improvements are for safety reasons.

WHEREAS, the Plattsmouth Airport Authority is considering the issuance of bonds at an amount up to \$150,000 to pay for improvements at the Plattsmouth Municipal Airport;

WHEREAS, as of November 30, 2015 the Authority had available in a construction fund \$138,680.67 which it shall use as part of its ten percent (10%) local match for the Federal Aviation Administration grant to relocate a portion of the parallel taxiway and relocation of three t-hangars project; and

WHEREAS, to repay the bonds the Plattsmouth Airport Authority's levy may exceed 3-1/2¢ on each One Hundred Dollars (\$100.00) of taxable valuation.

NOW THEREFORE, BE IT RESOLVED, that the City of Plattsmouth, Nebraska by its Mayor and City Council, authorizes the Plattsmouth Airport Authority to levy taxes exceeding $3-1/2\phi$ on each One Hundred Dollars (\$100.00) of taxable valuation as permitted pursuant to *Neb. Rev. Stat.* § 3-504(12) to the extent necessary to repay up to \$150,000 in bonds by the Plattsmouth Airport Authority to relocate a portion of the parallel taxiway and three t-hangars.

BE IT FURTHER RESOLVED that the Airport Authority's general levy is subject to review and modification by the City Council each year.

BE IT FURTHER RESOLVED that this Resolution will not be rescinded, amended, or repealed during the term of such bonds or any bonds issued to refund such bonds.

- Council Member Wiemer voluntarily withdrew her name as a candidate for 2016 Plattsmouth City Council President.
 - VOTE #6: 2 Votes for Kerns; 3 Votes for Porter; 2 Votes for Riese. With no one receiving a majority vote of the council as a whole, a seventh vote was required.
 - VOTE #7: 1 Vote for Kerns; 3 Votes for Porter; 3 Votes for Riese. With no one receiving a majority vote of the council as a whole, a eighth vote was required.

- VOTE #13: 4 Votes for Porter; 3 Votes for Riese. With no one receiving a majority vote of the council as a whole, a fourteenth vote was required.
- VOTE #14: 4 Votes for Porter; 3 Votes for Riese. With no one receiving a majority vote of the council as a whole, a fifteenth vote was required.
- VOTE #15: 4 Votes for Porter; 3 Votes for Riese. With no one receiving a majority vote of the council as a whole, a sixteenth vote was required.
- VOTE #16: 3 Votes for Porter. 4 Votes for Riese. With no one receiving a majority vote of the council as a whole, a seventeenth vote was required.
- VOTE #17: 2 Votes for Porter. 5 Votes for Riese.
