ITEM 8 A

Council member Kerns stated that he would be abstaining from any discussion or action on this item as his company, Kerns Excavating Co., is a potential bidder.

Steve Perry P.E., Olmsted & Perry Consulting Engineers Inc., stated that the CDBG Street and Water Improvements-Phase 2 Year 2 Project consists of two Project Contracts: Street Project is PC concrete repair and overlay on 6th Avenue from 6th Street to 8th Street and 7th Street from 5th Avenue; and the Water Main Project consists of three segments: Smith Avenue from 17th Avenue to 18th Avenue; Livingston Road from 2nd Avenue to A Street; and Rock Bluff Avenue from 13th Avenue to 16th Avenue. Bids would be open May 5, 2016 with a start date as soon thereafter as possible with a completion the end of August 2016. Motion by Brookhouser, seconded by Wiemer to authorize publication of Notice and Solicitation of sealed bids for the construction of CDBG Street and Water Improvements-Phase 2-NDED contract No. 14-CIS-104. ITEM 8 B

Jim Olmsted P.E., Olmsted and Perry Consulting Engineers Inc. and Jim Wells, The Wells Resource Group reviewed the consultant's preliminary study regarding feasibility of pretreating Schmidt wastewater for discharge into the City system. Mr. Olmsted stated that based on the results of the engineering study, it is their recommendation that Plattsmouth provides favorable consideration to providing final wastewater treatment services to Schmidt Trucking and proceeds with preparation of the necessary agreements based on the summarized points for terms, conditions and restrictions. Mr. Wells stated that our wastewater treatment plant is at a little less than half of maximum capacity and that at 85% to 90% capacity we would have to look at plans for upgrading the system. Wells stated that his recommendation is based on pumping 15,000 gallons a days (averaged over a 7 day period). Other findings in the consultant's preliminary study were discussed.
