- -Lot 3 and that part of Lot 2 Morehead Island Riverfront Development Subdivision Not Platted into Castaway Villa, Cass County, Nebraska; and
- -Commercial Lot 9, Morehead Island Development, a subdivision in Cass County, Nebraska.

Ervin Portis, City Administrator stated that the Plattsmouth Planning Commission received at their June 16, 2016 meeting and recommended approval. A notice was mailed to all taxing entities on June 7, 2016. On June 9 and June 16, 2016 the Notice of Public Hearing was published in the Plattsmouth Journal. With no one else coming forward to speak the Mayor closed the public hearing at 7:19 p.m.

Council member Riese introduced a resolution numbered and titled as follows: RESOLUTION NO. 16-007: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, DECLARING PORTIONS OF THE CITY OF PLATTSMOUTH TO BE BLIGHTED AND SUBSTANDARD.

Motion by Riese, seconded by Wiemer to adopt RESOLUTION NO. 16-007 by title only:

RESOLUTION NO. 16-007

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, DECLARING PORTIONS OF THE CITY OF PLATTSMOUTH TO BE BLIGHTED AND SUBSTANDARD.

WHEREAS, it is desirable and in the public interest that the City of Plattsmouth, Nebraska, undertake and carry out redevelopment projects in areas of the City which are determined to be substandard and blighted and in need of redevelopment;

WHEREAS, Nebraska Revised Statutes § 18-201 to § 18-2144, known as the Community Development Law, prescribes the requirements and procedures for the planning and implementation of redevelopment projects;

WHEREAS, Neb. Rev. Stat. § 18-2109 requires that, prior to the preparation by the community development agency of a City of a redevelopment plan for a redevelopment project, the Mayor and City Council as governing body of the City, by resolution, shall find and

determine that the area is a substandard and blighted area in need of redevelopment as defined in the Community Development Law;

WHEREAS, on July 5, 2016, 2016 at 7:00 p.m., a meeting of the Mayor and City Council of the City of Plattsmouth, Nebraska, was held at the Plattsmouth Public Library, 401 Avenue A, Plattsmouth, Nebraska in order to conduct a public hearing to determine whether certain areas of the City should be declared to be substandard and blighted and in need of redevelopment, as defined in and pursuant to the Community Development Law;

WHEREAS, a Notice of Public Hearing was published in the Plattsmouth Journal, a legal newspaper published in Plattsmouth, Nebraska, on June, 9, 2016 and June 16, 2016 and which Notice of Public Hearing described the time, date, place and purpose of the hearing and specifically identified the area to be considered as substandard and blighted and in need of redevelopment;

WHEREAS, the City mailed notice of the public hearing by first class, postage prepaid United States Mail on June 7, 2016 which is at least 10 days prior to the hearing, to all registered neighborhood associations whose area of representation is located in whole or in part within a one-mile radius of the area to be redeveloped and to the president or chairperson of the governing body of each county, school district, community college, educational service unit, and natural resources district in which the real property to be affected by such determination, which notice set out the time, date, place and purpose of the public hearing and included a map of sufficient size to show the area to be affected;

WHEREAS, at such meeting the public hearing was conducted, and all interested parties were afforded a reasonable opportunity to express their views respecting the designation of such area as substandard and blighted and in need of redevelopment, and the Mayor and City Council reviewed and discussed a Blighted and Substandard Area Designation previously prepared by RDG Planning & Design;

WHEREAS, the Mayor and City Council submitted the question of whether the area in question is substandard and blighted and in need of redevelopment to the Planning Commission of the City of Plattsmouth for its review and recommendation prior to the City Council meeting and the public hearing on July 5, 2016 and the Mayor and City Council reviewed and discussed recommendations received from the Planning Commission; and

WHEREAS, the Mayor and City Council desire to determine whether the specific area is substandard and blighted and in need of redevelopment in accordance with the Community Development Law.

NOW THEREFORE, BE IT RESOLVED by the City of Plattsmouth, Nebraska, that the following area located in the City of Plattsmouth, Cass County, Nebraska, legally described on Exhibit "A" hereto and depicted the map included as Exhibit "B" hereto, is hereby declared to be a substandard area in need of redevelopment pursuant to the Community Development Law, in that conditions which now exist in said area meet the criteria set forth in Nebraska Revised Statutes § 18-2103 (10) as described and set forth in the Blighted and Substandard Area Designation received by the City;

BE IT FURTHER RESOLVED that the above described area is hereby declared to be a blighted area in need of redevelopment pursuant to the Community Development Law, in that conditions which now exist in said area which meet one or more of the factors set forth in Nebraska Revised Statutes § 18-2103(11)(a) and at least one of the factors set forth in (i) through (iv) of Nebraska Revised Statutes § 18-2103(11)(b), as described and set forth in the Blighted and Substandard Area Designation received by the City;

BE IT FURTHER RESOLVED that such substandard and blighted condition is beyond the remedy and control solely by regulatory process and the exercise of police power and cannot be dealt with effectively by the ordinary operations of private enterprise without the aids provided by the Community Development Law, and the elimination of said substandard and blighted condition under the authority of the Community Development Law is hereby found to be a public purpose and declared to be in the public interest; and

BE IT FURTHER RESOLVED, that it is hereby found and determined that such substandard and blighted area is in need of redevelopment and is an eligible site for a redevelopment project under the provisions of the Community Development Law.
