John Trecek, Ameritas Investment Corp. stated that new regulations within the Federal Tax Code only allows Promissory Notes of this type to have a maturity date extending out 13 months. Mr. Trecek also stated that the interest rate for these Promissory Notes is 0.800% and recommended suspension of the statutory rule requiring reading an ordinance on three different days and that Ordinance No. 1912 be adopted tonight.
