September 19, 2016

A meeting of the City Council of the City of Plattsmouth, Nebraska was convened in open and public session at 7:09 o'clock p.m. on September 19, 2016 at Plattsmouth City Hall in Plattsmouth Nebraska. Present were Mayor R. Paul Lambert and Council Members: John Porter, Terry Kerns, Jeanie Brookhouser, Terry D. Tilson, Steve Riese, Joe Dugan, Wanda Wiemer and Doug Derby. 
