Erv Portis, City Administrator referenced the memorandum in the Council Packet material regarding the scope of services and fees from Steve Perry, Olmsted & Perry Consulting Engineers for the Lincoln Avenue Drainage Project. Motion by Brookhouser seconded by Grimshaw to approve a scope of services and fees from Steve Perry, Olmsted & Perry Consulting Engineers for the Lincoln Avenue Drainage Project. Following further discussion, ROLL CALL: Yes-Riese, Brookhouser, Wiemer, Porter, Derby, Kerns, Minahan and Grimshaw. No-None. Absent-None. Abstain-None. MOTION CARRIED.

ITEM 8 B

Pursuant to publication, Mayor Lambert opened a public hearing at 7:21 p.m. to hear and receive public comments with respect to the redevelopment plan entitled "Redevelopment Plan Highway

75, Bestmann and Oakhill Road Project Area 2018" which has been prepared for redevelopment of the following described real estate:

Bestmann Addition, Lot 2, Northwest ½ of the Northwest 1/4, except the road, of Section 13, Township 12 North, Range 13 East of Cass County, Nebraska;

Bestmann Addition, Lot 3A and ½ of adjacent Bestmann Drive, except Highway, of Section 13, Township 12 North, Range 13 East of Cass County, Nebraska;

Bestmann Addition, Lot 3B and ½ of adjacent Bestmann Drive of Section 13, Township 12 North, Range 13 East of Cass County, Nebraska; and

Bestmann Addition, Lot 4A replat and ½ of adjacent Bestmann Drive of Section 13, Township 12 North, Range 13 East of Cass County, Nebraska.

Said plan provides for the Project Area to be redeveloped by the construction of a commercial quick service restaurant in compliance with the city of Plattsmouth zoning for General Commercial and Civic Corridor Design Overlay Districts. Grant assistance from the City's Community Development Agency is proposed to be applied to pay a portion of the costs of such project, including site acquisition, site demolition and preparation, and grant in aid of construction. Trevor Rutten, 16108 Leeman Street, Bennington, Nebraska 68007 stated that the development project would be a great addition to the community. Mr. Rutten stated the business originally started in 1964 and is popular at Nebraska Football games and he appreciated the opportunity. With no one else speaking, Mayor Lambert closed the public hearing at 7:25 p.m.

ITEM 8 C

Council member Wiemer introduced a resolution numbered and titled as follows: RESOLUTION NO. 18-004: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA APPROVING A REDEVELOPMENT PLAN ENTITLED "REDEVELOPMENT PLAN HIGHWAY 75, BESTMANN AND OAKHILL ROAD PROJECT AREA 2018".

Motion by Wiemer seconded by Porter to approve RESOLUTION NO. 18-004 by title only:

RESOLUTION NO. 18-004

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA APPROVING A REDEVELOPMENT PLAN ENTITLED "REDEVELOPMENT PLAN HIGHWAY 75, BESTMANN AND OAKHILL ROAD PROJECT AREA 2018".

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, as follows:

Section 1. The Mayor and City Council of the City of Plattsmouth, Nebraska, hereby find and determine that pursuant to the provisions of Community Development Law (Sections 18-2101 to 18-2144, R.R.S. Neb. 2012, as amended), the Mayor and Council have by Resolution No. 13-008A, passed and approved on February 18, 2013, declared certain real estate within and adjacent to the City to be blighted and substandard after review by the City's Planning

Commission and published notice of hearing and public hearing as required by law (such area, as so determined, the "Blighted and Substandard Area"), and that the Blighted and Substandard Area includes the Project Area in the Redevelopment Plan Highway 75, Bestmann and Oakhill Road Project Area 2018.

Section 2. The Mayor and City Council further finds and determines that:

- (a) The redevelopment plan entitled "REDEVELOPMENT PLAN HIGHWAY 75, BESTMANN AND OAKHILL ROAD PROJECT AREA 2018" (the "Plan") relating to a certain portion of the Blighted and Substandard Area was referred and submitted to the Planning Commission (the "Planning Commission"), for a public hearing, review and recommendations;
- (b) Notice of the Planning Commission public hearing was published in the Plattsmouth Journal on January 18 and January 25, 2018, and that on January 16, 2018 that same notice of public hearing was mailed by certified mail, return receipt requested, to all entities whose tax receipts may be affected by approval of the Plan;
- (c) On February 15, 2018, the Planning Commission conducted a public hearing and received input on the Plan;
- (d) Following the public hearing, the Planning Commission approved Resolution No. PC 18-001 to recommend that the City Council approve the Plan.
- (e) The real estate described in the Plan is located within the Blighted and Substandard Area; and
- (f) Notice of a March 19, 2018 City Council public hearing to receive input and comments on the Plan was published in the Plattsmouth Journal on February 22 and March 1, 2018; and that the same notice was mailed on March 1, 2018 by certified mail, return receipt requested, to all entities whose tax receipts may be affected by implementation of the Plan.

Section 3. The Mayor and City Council further find and determine that the Community Development Agency of the City of Plattsmouth determined that the proposed land uses and building requirements in the redevelopment project area (defined and referred to in the Plan as the "Project Area") are designed with the general purpose of accomplishing, in conformance with the City's general plan, a coordinated, adjusted, and harmonious development of the City and its environs which will, in accordance with present and future needs, promote health, safety, morals, order, convenience, prosperity, and the general welfare, as well as efficiency and economy in the process of development, including, among other things, adequate provision for traffic, vehicular parking, the promotion of safety from fire, panic and other dangers, adequate provision for light and air, the promotion of the healthful and convenient distribution of population, the provision of adequate transportation, water, sewerage and other public utilities, schools, parks, recreational and community facilities and other public requirements, the promotion of sound design and arrangement, the wise and efficient expenditure of public funds and the prevention of the recurrence of insanitary or unsafe dwelling accommodations, or conditions of blight.

Section 4. The Mayor and City Council further find and determine that a cost-benefit analysis, attached as an exhibit to the Plan and incorporated herein by this reference, has been

prepared pursuant to the guidelines set forth in Section 18-2113, R.R.S., Neb 2012, and is hereby approved and adopted as the cost benefit analysis of the Agency with respect to the Plan. Such cost benefit analysis reflects positive impacts of the Project as described in the Plan.

Section 5. The Mayor and City Council further find and determine that the Community Development Agency, by approval of Resolution No. CDA 18-001 recommended that the Mayor and City Council adopt the Plan. In connection with such recommendation, the Agency reported to the Mayor and City Council that the proposed method and estimated cost of the acquisition and preparation for redevelopment of the Project Area and the estimated proceeds or revenue from the Project Area's disposal to redevelopers, if any; and a statement of the proposed method of financing the redevelopment project is set forth in the Plan and that further it has been stated to the Mayor and City Council that there will be no families displaced from the Project Area.

Section 6. The Mayor and City Council further find and determine that a public hearing was held on March 19, 2018, after notice of such public hearing was published in the Plattsmouth Journal on February 22 and March 1, 2018; and that notice of the March 19, 2018 public hearing was mailed on March 1, 2018 by certified mail, return receipt requested, to all entities as required by Section 18-2115, R.R.S. Neb 2007, whereby all persons desiring to be heard as to whether the Plan should be approved have been heard.

Section 7. Based upon the recommendation of the Community Development Agency and analysis and review of the Plan, the Mayor and City Council hereby find that (1) the Plan is feasible and in conformity with the general plan for the development of the City as a whole and the Plan is in conformity with the legislative declarations and determinations set forth in the Community Development Law; (2) the redevelopment project in the Plan (the "Project") would not be economically feasible without the use of tax-increment financing, (3) the Project would not occur in the Project Area without the use of tax-increment financing; and (4) that the costs and benefits of the Project, including costs and benefits to other affected political subdivisions, the economy of the community, and the demand for public and private services have been analyzed by the governing body and have been found to be in the long-term best interest of the community impacted by the Project.

Section 8. The Mayor and City Council hereby approve the Plan.
