#### ITEM 8 A

Council Member Kerns abstains from any discussion or action on this item as his company is a potential bidder.

Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc. stated that the first segment of this project is complete and Phase I is the relocation of 4,600 lineal feet of 12-inch diameter water main along the east side of US Highway 75 from Wiles Road north to Osage Ranch Boulevard and is ready to be let for bidding. Mr. Perry recommends a bid date of June 14, 2018 with a start date this fall and completion by early winter. The City has a cost share agreement with Nebraska Department of Transportation (NDOT) that reimburses 80% of the total project cost to NDOT and the City the remaining 20%. Proposed interim financing will be a Nebraska State Revolving Fund loan agreement in the amount of \$876,000.00-80% will be reimbursed by NDOT and the remaining 20% will be the City's responsibility. There is some principle forgiveness on the City share. Motion by Riese seconded by Derby to Authorize the Advertisement For Bids for the US Highway 75 Utility Relocations-Wiles Road to Osage Ranch
