Erv Portis, City Administrator stated that ATV/UTV/Golf Carts are permitted by statute with restrictions. Originally use was to be for to and from the Riverfront but it has broadened. The restrictions that the City is proposing are: Allow use throughout the city; prohibit use from sunset to sunrise; can only run up to 30 mph; cannot be used on or to cross a highway; must be 18 years of age with a valid Operators License; ATV/UTV/Golf Cart must be insured and registered; up to a \$500.00

fine for violations; 2 year revocation if violate rules; copy of ordinance will be provided at the time of issuance of a permit. Helmet requirements were also discussed including the requirements for any passengers. The requirement of the use of seat belts was also questioned.
