Absent-Wiemer. Abstain-None. MOTION CARRIED. Erv Portis, City Administrator read ORDINANCE NO. 1950 in to the record by title only.

ITEM 9 A

Motion by Kerns seconded by Brookhouser to receive the Housing Authority of the City of Plattsmouth, Nebraska Basic Financial Statements, Required Supplemental Information and Supplemental Information for Year Ended June 30, 2018 and direct the clerk to place on file. ROLL CALL: Yes-Riese, Kerns, Brookhouser, Muller, Minahan, Derby and Grimshaw. No-None. Absent-Wiemer. Abstain-None. MOTION CARRIED.

Council member Kerns stated that he would be abstaining from any discussion or action regarding ITEM 9 B; ITEM 9 C; ITEM 9 D; and ITEM 9 E as he has a conflict of interest.

Erv Portis, City Administrator stated that ITEM 9 B was authorized under Resolution No.018-010: Construction Services Agreement; ITEM 9 C was competitively bid; ITEM 9 D was Flood Related and Kerns Excavating Company is listed in the City Emergency Operations Plan; and ITEM 9 E was a water issue but due to the Flood the issue was considered an emergency and Kerns Excavating Company is listed in the City Emergency Operations Plan.

ITEM 9 B

Motion by Muller seconded by Derby to approve Invoice No. 14960 submitted by Kerns Excavating Company in the amount of \$2,868.50 for Emergency Repair work for February 2019 (Replace curb stop at 2515 S. 15th St.-\$661.50; Water main leak at 311 Hillcrest Dr.-\$980.00; Water main leak at S. 10th St.-\$672.00; Water main leak on Webster Blvd.-\$355.00; and Manhole on 18th St-City Park Shop-\$200.00) and authorize payment. ROLL CALL: Yes-Riese, Grimshaw, Derby, Brookhouser, Minahan and Muller. No-None. Absent-Wiemer. Abstain-Kerns. MOTION CARRIED.

Motion by Grimshaw seconded by Brookhouser to approve Invoice No. 14973 submitted by Kerns Excavating Company in the amount of \$3,324.00 (Bay Road water well sandbagging-\$3,040.00; and Excavating sand/trash from Rhylander Park sediment structure to allow pumping-\$284.00) and authorize payment. ROLL CALL: Yes-Brookhouser, Derby, Grimshaw, Minahan, Muller and Riese. No-None. Absent-Wiemer. Abstain-Kerns. MOTION CARRIED.

ITEM 9 E

Motion by Brookhouser seconded by Derby to approve Invoice No. 14968 submitted by Kerns Excavating Company in the amount of \$2,106.00 for Emergency Repair Work for March 2019 (6" main at 408 4th Ave-\$783.00; and water leak at 15104 Rock Bluff Ave on 2" galvanized line-\$1,323.00) and authorize payment. ROLL CALL: Yes-Grimshaw, Minahan, Derby, Riese, Brookhouser and Muller. No-None. Absent-Wiemer. Abstain-Kerns. MOTION CARRIED.

ITEM 9 F

Motion by Grimshaw seconded by Riese to approve the appointment of Danial Markham as a new probationary member to the Plattsmouth Volunteer Fire Department and the addition of his name to the Roster. ROLL CALL: Yes-Riese, Muller, Minahan, Kerns, Grimshaw, Derby and Brookhouser. No-None. Absent-Wiemer. Abstain-None. MOTION CARRIED.

ITEM 9 G

Erv Portis, City Administrator discussed the Flood Disaster Recovery and the short-term and long-term next steps:

- -Between March 14, 2019 and March 15, 2019 the Missouri River rose from 16 feet to 40.65 feet -March 14, 2019 the City declared a Water Emergency-All non-sanitary, non-essential use of water must be discontinued
- -March 14, 2019 the City notified NDEQ that both the water and wastewater systems were taken off-line. The City operationalized the Cass County Rural Water District 1 (CCRWD1) emergency connection to provide water on a short-term, restricted-use basis to the City.
- -A Booster Pump was purchased and installed at CCRWD1 to help keep pace filling the City tanks to meet usage at a cost of \$32,000.00
- -March 20, 2019 the City's Public Works Director issued a Water Emergency Order to supplement the Water Emergency Declaration issued March 14, 2019-requested a voluntary 30% reduction for all residents, industrial, commercial, and institutional water uses. The Order also stated that the water is safe to drink.
- -The City has two (2) pools: Indoor pool will be used for therapeutic use only; Outdoor Pool will not open until the Water Emergency ends (it is anticipated that the Water Emergency will end after the season so it will not be put in to operation this year).
- -Well Field: All five (5) wells were affected. All berms were scoured; Well #4-the well house was destroyed; power lines tilted or down.

- -Water Treatment Plant: All of the first floor (10-11 feet of water above floor) was inundated; Clear Well was inundated; 2nd floor-filters and electrical assume affected; clarifier appears ok; pumps may be ok.
- -Wastewater Treatment Plant: Every system component was inundated including all electrical in the entire facility
- -Flood Insurance claims have been filed for the Water Treatment Plant, Wastewater Treatment Plant and the Wells.
- -FEMA Public Assistance application process to begin Wednesday, April 3, 2019
- -Short Term Goals: Drinking Water operational in 6 months or less; Wastewater operational in 6 months or less but unsure if that is realistic until the full assessment is done; Hoping FEMA can expedite the process for cash advances due to cash flow issues
- -Long Term Goals-Water: Review the Water Study done by Olmsted & Perry Consulting Engineers a number of years ago and look at the options: flood proofing-how high do we go; and contracting with MUD to purchase water wholesale. Wastewater: Repair our system which is a gravity system; Build a new plant-where to locate and funding options
- -Money is available through NDEQ for Planning (3-5 yrs at .25% interest)

ITEM 9 H

Council member Grimshaw introduced an ordinance numbered and titled as follows: ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, TO AFFIRM THE EMERGENCY DECLARATION ISSUED MARCH 13, 2019, IN RESPONSE TO FLOODING ON THE MISSOURI AND PLATTE RIVERS; TO ACKNOWLEDGE THE CONTINUATION OF SUCH EMERGENCY AND THE CITY'S URGENT NEED TO RESTORE CERTAIN PUBLIC INFRASTRUCTURE: TO AUTHORIZE THE WAIVER OF COST ESTIMATES, ADVERTISEMENT OF BIDS, SINGLE EXPENDITURE LIMITATIONS, AND OTHER REOUIREMENTS PERTAINING TO THE MANNER IN WHICH THE CITY ENTERS CONTRACTS FOR THE PURPOSE OF RESPONDING TO, AND RECOVERING FROM, DAMAGE TO CERTAIN PUBLIC INFRASTRUCTURE CAUSED BY THE FLOODING: TO DELEGATE TO THE CITY ADMINISTRATOR LIMITED AUTHORITY TO MAKE SUCH WAIVERS AND ENTER SUCH CONTRACTS FOR SINGLE EXPENDITURES UP TO \$50,000.00; TO REPEAL ALL ORDINANCES IN CONFLICT: TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM AND FOR POSTING AS AN EMERGENCY ORDINANCE; AND TO PROVIDE AN EFFECTIVE

Council discussed putting a 6 to 12 month limitation to authorize the waiver of cost estimates, advertisement of bids, single expenditure limitations, and other requirements pertaining to the manner in which the city enters contracts for the purpose of responding to, and recovering from, damage to certain public infrastructure caused by the flooding and to delegate to the city Administrator limited authority to make such waivers and enter such contracts for single expenditures up to \$50,000.00. Following further discussion, Grimshaw withdrew her motion and Derby withdrew his 2nd.

Motion by Grimshaw seconded by Derby to suspend the statutory rule requiring reading an ordinance on three different days and that Ordinance No. 1952 be adopted on first reading by

title only with the addition of the 6 month limitation for waivers and expenditure limitations delegated to the City Administrator.

Erv Portis, City Administrator read Ordinance No. 1952 by title only: AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, TO AFFIRM THE EMERGENCY DECLARATION ISSUED MARCH 13, 2019, IN RESPONSE TO FLOODING ON THE MISSOURI AND PLATTE RIVERS; TO ACKNOWLEDGE THE CONTINUATION OF SUCH EMERGENCY AND THE CITY'S URGENT NEED TO RESTORE CERTAIN PUBLIC INFRASTRUCTURE; TO AUTHORIZE THE WAIVER OF COST ESTIMATES, ADVERTISEMENT OF BIDS, LIMITATIONS, SINGLE **EXPENDITURE** AND **OTHER** REQUIREMENTS PERTAINING TO THE MANNER IN WHICH THE CITY ENTERS CONTRACTS FOR THE PURPOSE OF RESPONDING TO, AND RECOVERING FROM, DAMAGE TO CERTAIN PUBLIC INFRASTRUCTURE CAUSED BY THE FLOODING, FOR A PERIOD NOT TO EXCEED SIX MONTHS OR, IF SOONER, UNTIL THE DATE SUCH EMERGENCY EXPIRES; TO DELEGATE TO THE CITY ADMINISTRATOR LIMITED AUTHORITY TO MAKE SUCH WAIVERS AND ENTER SUCH CONTRACTS FOR SINGLE EXPENDITURES UP TO \$50,000.00, FOR A PERIOD NOT TO EXCEED SIX MONTHS OR, IF SOONER, UNTIL THE DATE SUCH EMERGENCY EXPIRES; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM AND FOR POSTING AS AN EMERGENCY ORDINANCE; AND TO PROVIDE AN EFFECTIVE DATE to clarify the addition of the 6 month limitation for waivers and expenditure limitations delegated to the City Administrator.

ROLL CALL: Yes-Brookhouser, Derby, Grimshaw, Kerns, Minahan, Muller and Riese. No-None. Absent-Wiemer. Abstain-None. MOTION CARRIED. Erv Portis, City Administrator read ORDINANCE NO. 1952 in to the record by title only. Council member Brookhouser moved for final passage of Ordinance No. 1952 on 3rd and final reading by title only, which motion was seconded by Riese. ROLL CALL: Yes-Kerns, Riese, Brookhouser, Muller, Derby, Minahan and Grimshaw. No-None. Absent-Wiemer. Abstain-None. MOTION CARRIED. Erv Portis, City Administrator read ORDINANCE NO. 1952 in to the record by title only.

ITEM 9 I

Jim Olmsted, Olmsted & Perry Consulting Engineers Inc. along with Steve Perry and Jeff Frey were present. Jim Olmsted stated the 2019 Flood event severely damaged the municipal wastewater treatment plant and the municipal water treatment plant. Mr. Olmsted recommended the City seek a qualified treatment plant construction contractor as they will be better equipped to comply with safety issues and complete the more complicated electrical repairs and assessments which must be performed under electrical codes, regulations and requirements. Three construction contractors (Building Crafts Inc., of Red Oak, Iowa; Judds Bros. Construction Co., of Lincoln, Nebraska; and Eriksen Construction Co., of Blair, Nebraska) were asked to submit proposals to perform the recommended services on a time and materials basis and all proposals were similar. Based on the following criteria: 1) knowledge and recent experience

with the existing treatment plant; and 2) experience in working with the City of Plattsmouth, Mr. Olmsted recommended the city select Building Crafts Inc. for the emergency repair contract.

Motion by Riese seconded by Muller to approve a contract, as an emergency procurement, between the City and Building Crafts Inc., whereby Building Crafts Inc. will perform certain damage assessment, cleanup, and repair services as necessary to restore operations at the City's wastewater treatment plant, on a time and materials basis, and upon such other terms as may be recommended by the City Engineer and reviewed by the City Attorney, and authorize the Mayor to execute a contract for such services upon such terms. ROLL CALL: Yes-Muller, Grimshaw, Minahan, Derby, Brookhouser, Riese and Kerns. No-None. Absent-Wiemer. Abstain-None. MOTION CARRIED.
