#### ITEM 7 C

Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc. gave a power point presentation showing the extensive damage/severe erosion that was done at the boat ramp, park and E. Main Street/Dock Road due to the Flood of March 2019. There were eleven major work items identified: major debris and rubble/silt removal; PCC and ACC pavement removal and replacement; roadway base and sub-base reconstruction; major off-site fill required; drainage culvert replacement; roadway shoulder fill; stone rip-rap replacement; crushed rock parking replacement; picnic area topsoil replacement and seeding; overhead power restoration; and

floating dock replacement. The estimated costs to restore the area to pre-flood condition are: \$795,300.00 for park area and boat ramp; and \$847,800.00 for Dock Road. Options were discussed. Mr. Perry will consider options and prepare a report with recommendations and cost estimates to present at the next City Council Meeting. NO ACTION TAKEN.

Community Center-are beginning to put together a plan for re-opening but unsure of rules and restrictions. Senior Center-will remain closed through the month of June and will re-evaluate prior to June 30, 2020. Baseball-Guidelines have been set for the reopening of youth baseball-practices can begin June 1 under specific guidelines; games can begin June 18, also under specific guidelines; should insurance be required and if so, how much. Library-will continue as is (curb side) at this time. NO ACTION TAKEN.
