Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., reviewed the 8th Street and Ave A Sanitary Sewer Extension Project. Mr. Perry stated this project will provide services to the Old Historic High School Building and properties along Avenue A, with future tie-on available to the Plattsmouth Early Childhood Center and the First Baptist School. To coordinate with the renovations at the Old Historic High School Building, this project is set to bid May 31, 2023 with completion date around the end of July 2023. Mr. Perry recommends approval. Motion by Muller seconded by Brookhouser to authorize the solicitation of bids for the 8th Street and Ave A Sanitary Sewer Extension Project. Steve Perry PE, Olmsted & Perry Consulting Engineers Inc., discussed the 2023 PC Concrete Street Repair Project with Council. Mr. Perry detailed how these critical repairs were part of the 2022 street repair schedule but was delayed due to weather. He confirmed that this repair project will not affect other street repair plans for the year. Mr. Perry recommends approval and a project bid date of May 31, 2023. Following discussion, Motion by Forrest seconded by Minahan to authorize the solicitation of bids for the 2023 PC Concrete Street Repair Project. Mr. Perry indicated that this project was originally identified by FEMA to be an alternate project related to the City boat ramp and Doc Road 2019 flood recovery work. The original contract was bid in July 2021 with award contingent upon FEMA funds, no FEMA funds were released, so the project was put on hold in August 2022. Now with the anticipated release of FEMA funds for this project Mr. Perry recommends relaunching the project with a bid date of May 31, 2023. Following discussion, Motion by Forrest seconded by Clark to authorize the solicitation of bids for the Oakmont Drive Water Main Improvement Project (2019 Flood Recovery Alternate Project PW#88688). The money will be presented to the City to purchase and license the vehicle.
